NOTE: Every case is different. Sentencing depends greatly upon the unique circumstances of each case (including, but not limited to, victim cooperation, other evidence available & defendant's criminal history). The above cases are provided to demonstrate the range of sentences for similarly charged cases.

NP = Nolle Prose (i.e., charge is dropped)

NC = Nolo Contendre or "no contest" plea

When adjudication is withheld, once the defendant successfully completes probation, the felony doesn't show up on their record as a conviction (this is not uncommon for first time offenders)

SO = Sex Offender conditions ordered for defendant's probation
